### **ACTIVE MEMBER.....\$150**

(Installer or designer state permitted or formerly permitted by the State of NH or pumper or certified evaluator)

### **ASSOCIATE MEMBER.....\$75**

(Installer, designer state permitted or formerly permitted by the State of NH or pumper or certified evaluator employed by, in partnership with, or a corporate officer in a company currently represented by an active member)

### **AFFILIATE MEMBER.....\$100**

(Individuals not licensed as an installer, designer, pumper or certified evaluator but having an interest in the industry and the goals/purposes of the Association)

### **PUBLIC SECTOR MEMBER.....\$50**

(Individuals employed in governmental agencies, not state permitted, and/or not engaged in the design/installation, pumping or evaluation of septic systems)

### **Dues Proration Schedule for Active Memberships:**

September 1 - November 30: Pay full current year's dues (\$150)

March 1 - May 31: Pay 50% of current year's dues (\$75)
